Re: Change of online system for EHC services – Webstar to PharmOutcomes and the utilisation of PharmOutcomes for further Public Health Commissioned Services.

I am writing to inform you that following a full service review the current contract for the online EHC system held with Webstar Service PACT will be ending on 31<sup>st</sup> March 2018. This will be provided by PharmOutcomes from 1<sup>st</sup> April 2018.

PharmOutcomes is a web-based system which helps community pharmacies provide services more effectively and makes it easier for commissioners to audit and manage these services.

PharmOutcomes will now be used to record all the Bury Council Public Health Commissioned Services including: EHC, Chlamydia Screening and Treatment, Needle exchange and supervised consumption and NRT. The platform will be made available on the 1<sup>st</sup> April 2018 for the following services:

- EHC
- Needle exchange and
- Supervised consumption

For the above services you will not have to submit paperwork for payment as you have done previously, as pharmoutcomes will generate this invoice on your behalf.

Chlamydia Screening and Treatment and the NRT will go live on this platform from the 1<sup>st</sup> May 2018, thus in the interim please record and submit claims for both these services as you have been doing so to date.

Payments for the above services will now be processed by CPGM Healthcare Ltd (CHL) on behalf of Bury Council. For CHL to process these payments they will require your pharmacies banking information. Thus, can we request that you complete and return the form attached (as instructed on the form) to CHL by Friday 20<sup>th</sup> April 2018.
