Dear Contractors,

Over the last few days, Greater Manchester Local Pharmaceutical Committee (GMLPC) have received several queries relating to the forthcoming GMLPC election and the governance and assurance process regarding the commissioning of Community Pharmacy COVID-19 designated vaccination sites. GMLPC have provided a response to both these queries below.

GMLPC Elections

GMLPC is a committee of pharmacy contractors in Greater Manchester (GM) that is recognised by NHS England under the NHS Act 2006 as the body representing the owners of the community pharmacies in the LPC area. The LPC is a statutory organisation governed by its <u>constitution</u>. The LPC Constitution is a key document setting out the membership of the committee and the constitutional rules under which the LPC operates including the election process. This must be adhered to as per the governance requirements of the LPC.

GMLPC contractors voted for an amendment to the constitution in June 2020. The first amendment was proposed under section 13.2. The second amendment was proposed under section 3.5.7. Namely that, due to the current COVID-19 pandemic, GMLPC planned to defer the GMLPC elections originally scheduled for later that year for a period of up to six months to enable business continuity in the service provided to community pharmacy and secondly, to tighten the governance around fit and proper person under section 3.5.7.

Following a governance review, discussions at committee level and further to the recent amendment to the LPC constitution; GMLPC contractors were consulted and voted for the deferral of the Greater Manchester LPC election for a period of six months on 26th August 2020. The vote passed with 317 contractors voting in favour of the deferral of the elections and none against (100%). In terms of the revised timeframes, it was agreed that the new election process would commence in January 2021, to be concluded in March 2021 with the new committee being formed and appointed in April 2021. The proposal to defer the elections for a period of six months enabled the LPC to maintain robust continuity of service and support to contractors in GM in light of the ongoing COVID-19 pandemic.

It is a constitutional requirement for the LPC election process to be undertaken every four years and this process needs to be completed in the agreed timeframes as voted for by GMLPC contractors. The LPC have a statutory duty to adhere to the agreed timelines relating to the postponement of GMLPC elections and to ensure that a new committee is appointed in April 2021.

GMLPC contractors have been provided with prior notification of the commencement of the election process on 23rd December 2020. Subsequently, a number of reminders have also been sent via a number of channels to ensure that all independent contractors have been provided with the opportunity to submit nominations before the deadline.

LPCs follow the election process as outlined in PSNC guidance to ensure that the election process will be completed in the agreed timeframes. In this case, it is a requirement for the election process to completed by March 2021 to enable the new committee to be formed and appointed in April 2021.

As this timeline has been voted and agreed on by contractors; any changes in the scheduled agreement will consequently delay the appointment of the new committee and therefore would be a breach of LPC governance and the constitution. As Returning Officer, I can confirm that the LPC has received applications from a number of independent contractors and therefore an election will take place. This is the opportunity for independent contractors to vote for the individuals who are best placed to represent community pharmacy in GM for the next four years.

On this basis, the LPC is constitutionally unable to delay the election process because members voted for a delay that still ensured that the new committee would be in place by April 2021. Due to the tight timelines, The LPC cannot therefore extend the deadline for nominations.

Pharmacy COVID-19 designated vaccination Sites Process

NHS England & NHS Improvement (NHSE/I) sent communications regarding community pharmacy participation in the COVID-19 vaccination programme to all contractors across the country on 30Th November 2020. Greater Manchester Health & Social Care Partnership (GMHSCP) also sent a communication out to all contractors on 30th November 2020 with a deadline to complete the expression of interest (EOI) form by the 6th December 2020. Details were also communicated to all contractors by GMLPC.

NHS England and Improvement regional teams commissioned selected community pharmacy contractors who were able to demonstrate that they would meet the requirements to provide a COVID-19 vaccination service from pharmacy-led designated sites. This included being able to deliver a minimum of 1,000 vaccines each week and to offer vaccinations for twelve hours a day, 7 days a week.

The Role of NHS England and Improvement

NHS England and Improvement stated that they expected to commission fewer community pharmacy than PCN led centres as they did not expect the majority of contractors to be able to meet the requirements. A nationally agreed designation process was established to provide assurance that all pharmacy-led sites administering COVID-19 vaccination met the required criteria. A number of national webinars have since been arranged and communicated by the LPC in the newsletter. The webinars have been informative in sharing learning from PCN designated sites and to help community pharmacy sites. The service was subsequently commissioned as a Local Enhanced Service by NHSE/I.

NHSE/I have therefore been responsible for the assurance and commissioning of community pharmacies across England for this service.

The Role of the LPC

The role of the LPC was to ensure updates and supporting information provided by NHSE/I were effectively cascaded to contractors to enable them to submit their expressions of interest within the required timeframe. Details needed were specific to each site and contractor.

It is notable that NHSE/I provided a short deadline for submissions, however a large number of contractors did submit within the required timeframe. Every EOI was scrutinised by NHSE/I against their nationally agreed assurance framework on a number of parameters including meeting the service specification, workforce modelling, workflow, processes, maintaining social distancing, infection control protocols, approach to collaborative working and filling any recognised gaps in current service provision.
