The PLO initiative represents a significant step forward in empowering patients to manage the ordering of their repeat prescriptions. This approach will bring the following key benefits:

- 1. **Reduced Medicine Waste** By enabling patients to order only the medications they need; PLO will help significantly reduce unnecessary medicine waste.
- 2. **Better Patient Control** Patients will have greater autonomy and understanding of their repeat medication, fostering improved medication management.
- 3. **Improved Safety** Avoiding unnecessary stockpiling of medication reduces the risk of confusion and misuse, improving patient safety.

- 4. **Time Saving** For both GP practices and community pharmacies, PLO will free up valuable time currently spent on ordering, chasing and processing repeat prescriptions or responding to related queries.
- 5. **Building relationships** PLO supports the relationship between community pharmacy and general practice/ PCN across GM.

During the webinar, representatives from the Medicines Optimisation Teams, NHS Greater Manchester ICB and Community Pharmacy Greater Manchester (CPGM) will cover a wide range of PLO related topics including:

- An overview of the process of PLO.
- The GM approach for the roll out and implementation.
- The implications and benefits for pharmacies and patients.
- The process of identifying patients who will need additional support with managing the process of ordering their repeat medication "vulnerable patients".
- Best practice and support resources for community pharmacies from CPGM.
- Q&A section to answer any PLO-related queries.
